<sup>1</sup> - The permitted monthly or annual tonnage each landfill is allowed to accept.

<sup>2</sup> - Location is used to indicate whether waste received was from an in-state or out-of-state entity/location.

<sup>3</sup> - MSW (Municipal Solid Waste) is calculated by totaling the residential and commercial waste received at each landfill.

<sup>4</sup> - Other Waste includes industrial waste, construction/demolition (c&d), petroleum contaminated soil (psc), sewage sludge, industrial sludge, drilling mud, "other special waste", bulky goods disposed, waste tires, asbestos waste, car wash residue, miscellaneous waste and "other fee exempt tons" which are all categories each in-state landfill are required to report the tonnages on the monthly tonnage report.

<sup>5</sup> - Free Day tonnage is the amount of tons each landfill accepted from residents on the monthly required "free day" as per WV Code §22-15-7.
